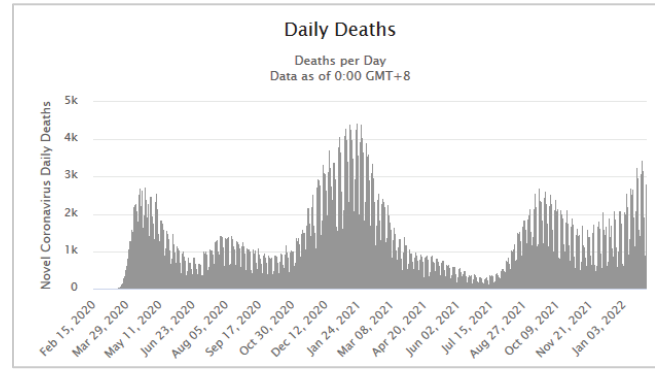
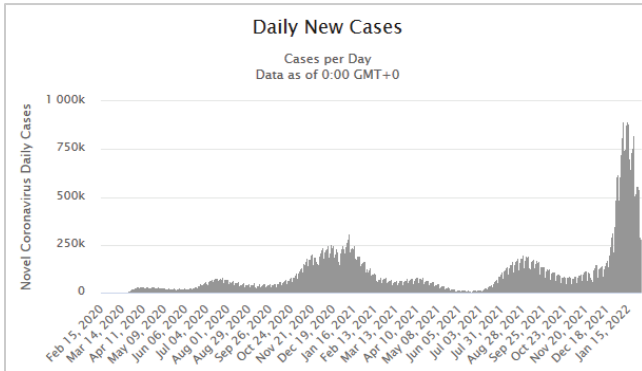


January 31st 2022 Covid Handbook Update <http://the9thgrader.com/>

- Omicron variant surge over** – (Two charts below) Beginning from a low point in early November 2021, the number of daily Covid cases rose exponentially as expected for the Omicron variant due to its high transmission attribute.



Omicron infections rose 300% above in any prior Covid wave. However, also as expected, the Omicron crashed just as quickly. Also, the Omicron variant was far less deadly than prior Covid waves, 3x the number of cases, but 2/3rds the number of deaths. 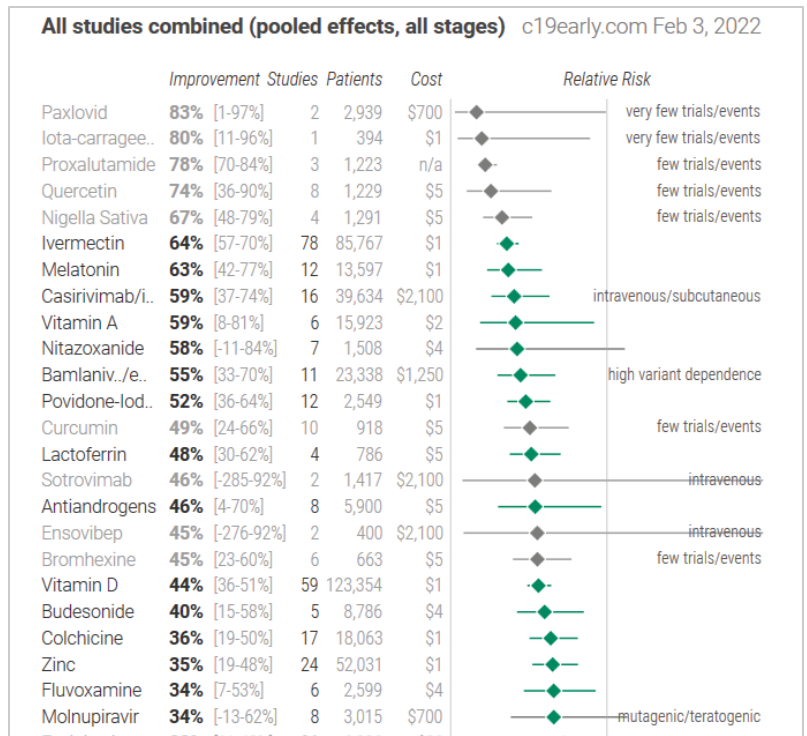
- Vaccine deaths and adverse events continue to rise** far above all other FDA approved vaccines. (table below)

4. **Supreme Court of the United States (SCOTUS) strikes down Biden's mandatory vaccination requirement for businesses with over 100 employees - 1/13/22 Reuters** *The U.S. Supreme Court on Thursday blocked President Joe Biden's COVID-19 vaccination-or-testing mandate for large businesses - a policy the conservative justices deemed an improper imposition on the lives and health of many Americans - while endorsing a separate federal vaccine requirement for healthcare facilities. It ruled 6-3, with the six conservative justices in the majority and three liberal justices dissenting, in blocking the rule involving large businesses - a policy that applied to more than 80 million employees.*

5. **Supreme Court of the United States (SCOTUS) upholds Biden's mandatory vaccination requirement for healthcare workers - 1/13/22 Reuters** *The vote was 5-4 to allow the healthcare worker rule, which requires vaccination for about 10.3 million workers at 76,000 healthcare facilities including hospitals and nursing homes that accept money from the Medicare and Medicaid government health insurance programs for elderly, disabled and low-income Americans. Two conservatives, Chief Justice John Roberts and Justice Brett Kavanaugh, joined the liberals in the majority in that case.*

6. **John Hopkins study says lockdown did little to curb Covid deaths – 1/31/22 Washington times** *Lockdowns had little or no impact on COVID-19 deaths, new study shows* *Lockdowns in the U.S. and Europe had little or no impact in reducing deaths from COVID-19, according to a new analysis by researchers at Johns Hopkins University. The lockdowns during the early phase of the pandemic in 2020 reduced COVID-19 mortality by about 0.2%, said the broad review of multiple scientific studies. "We find no evidence that lockdowns, school closures, border closures, and limiting gatherings have had a noticeable effect on COVID-19 mortality," the researchers wrote. But the research paper said lockdowns did have "devastating effects" on the economy and contributed to numerous social ills. "They have contributed to reducing economic activity, raising unemployment, reducing schooling, causing political unrest, contributing to domestic violence, and undermining liberal democracy," the report said.*

7. **USA very likely near 100% national adult immunity between vaccination and unvaccinated infections resulting in natural immunity - this is my personal estimation** based upon the vaccination rates of adults and the recent sweeping Omicron variant wave. As reported, [75.4% of the U.S. population has received at least one shot, AND 63.5% or 211 million have been fully vaccinated, AND that 75 million total reported cases are logged, \(which is estimated to be about 25% less than actual, due to people like myself and wife who never reported and self-tested at home\) AND that we have an estimated 330 million people in the U.S. \(not all citizens\) AND that roughly 73 million are under 18, AND if they believe their own statistics, only 2% of Covid cases are break through](#), we end up with an equation that looks like this; (330m-73m kids=257mil, allow for 10% of <18 being part of Covid cases 257m+7m= 264m adjusted adults, 264m adults -211m fully vaccinated =53m net unvaccinated adults. Now, because they say that 60%-90% of all Covid cases are unvaccinated, 75m total cases x 75% =56m of unvaccinated who got Covid. We

are 3 million over the total population in this equation thus establishing over 100% immunity between the two classes of people, “vaccinated” and “unvaccinated but caught Covid and now have natural immunity”. I agree this is not a precise calc, but again, I’m only a 9th grader. Besides, you’re not going to find enough “actual” numbers anywhere, because our government doesn’t track nor could it track, all the required data. [Another article estimates 97% adult immunity](#) but based upon logic I’m not sure I can really agree with. *“The month of January 2022 has witnessed the fastest rise in Covid-19 cases since the pandemic began. At its peak a year ago, the weekly increase in new cases had reached 1.75 million. The peak earlier this January had reached 5.6 million. Nevertheless, based on the most recent government data, as of January 24 only about three Americans in a hundred could conceivably transmit Covid-19 to someone. In other words, an estimated 97.0 percent of people in the United States pose no threat to anyone of spreading the virus. Even with such a rapid influx of new cases, nearly 85 percent of total cases are recovered, meaning not only that those people are no longer threats, but also that they now have the strongest form of immunity against Covid-19.”* **This article incorrectly assumes** that anyone with immunity cannot spread the virus, which is not true, for sure vaccinated people can get and spread Covid, we do not yet have data to know about unvaccinated who caught Covid and recovered.

What does this mean? We are actually at a very important crossroad, because by the end of February, Covid infection data will either begin to swing in a clear direction or not swing at all. I’m guesstimating (*based upon the collective review of Covid literature*) that it will swing. What might the swing be? We will begin to see that those who got vaccinated are stuck on a train of ever increasing and less effective booster shots to remain infection free, while those who have natural immunity will not have much of a care and will be very rarely reinfected. In other words, natural immunity will prove itself supreme and this whole vaccination program will show itself to be what it is, a \$100 billion dollar taxpayer funded injection into the pharmaceutical industry. Consider that the Biden administration is claiming “*only vaccination is effective*”, but numerous studies prove that a lie. (*See the Covid Handbook*) So if natural immunity is better (*and it is*) and the withholding of advising the public to take the readily available over the counter remedies (*see bullet 3 above*) will show the current administration to be well executioners of a large quantity of people who died from Covid infection and destroyers of the U.S. economy for no good reason other than misguided pride and a desire to shred the U.S. Constitution by illegal control of the American people.

8. **Regen-Cov (Covid monoclonal cocktail) dropped by FDA for emergency use** - [FDA Limits Use of Regeneron & Lilly's COVID Antibody Cocktails, 1/25/22](#) *The FDA announced that it has revised the emergency use authorization (EUA) for two cocktail antibody drugs — Eli Lilly’s LLY bamlanivimab plus etesevimab, and Regeneron Pharmaceuticals’ REGN REGEN-COV (casirivimab plus imdevimab). The revision for these two cocktail COVID-19 drugs limits their use in patients who have been infected or exposed to a coronavirus variant that is susceptible to these treatments. The FDA stated that Eli Lilly and Regeneron’s COVID-19 drugs are currently not authorized for use in any U.S. states, territories, and jurisdictions. However, the FDA mentioned that these drugs may be authorized for use in certain regions where there is a chance of COVID-19 infections due to coronavirus variants susceptible to these treatments.*

9. **The researchers who supported Dr Fauci got over \$50 million in new funding.** [1/25/22 The Epoch Times](#) – “*Four prominent scientists who played key roles in shaping the public narrative about the origins of COVID-19 received substantial increases in grant money from the institute headed by Dr. Anthony Fauci in the subsequent two years, a review of funding data by The Epoch Times has found. Three of these scientists—Kristian Andersen, Robert Garry, and Michael Farzan—were advisers to a teleconference organized by Fauci held on Feb. 1, 2020, in response to increasing public questions about the origins of the virus.*”

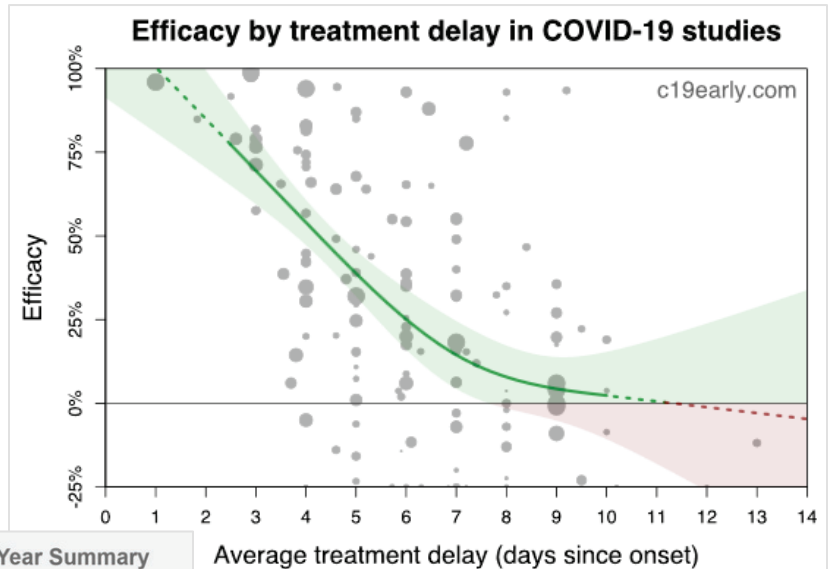

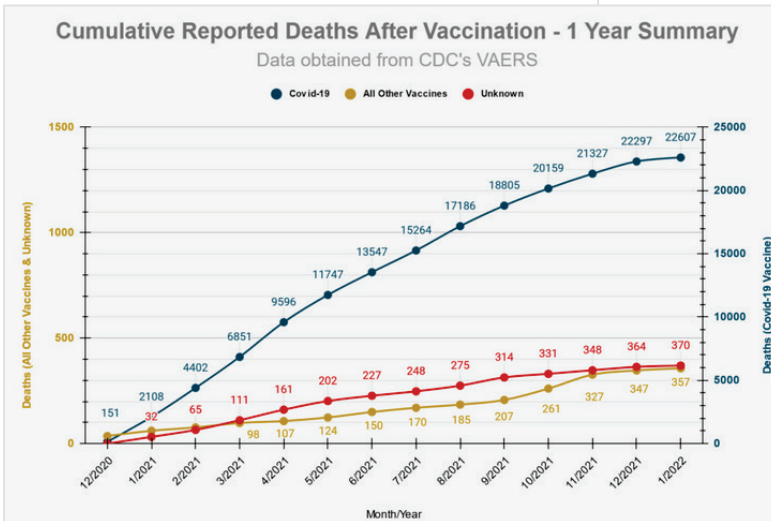
11. **CDC and Johns Hopkins studies show strength and duration of natural immunity protection** [1/31/22 CDC and Johns Hopkins studies show strength and duration of natural immunity protection](#) - *Two newly released studies show the power of natural immunity following recovery from COVID-19 sickness. The Centers for Disease Control and Prevention (CDC) says "previous SARS-CoV-2 infection also confers protection against severe outcomes in the event of reinfection." Johns Hopkins found that natural immunity developed from prior variants reduced the risk of infection with the Omicron variant. Natural immunity was six times stronger during the Delta wave than vaccination, according to one news report about the CDC study. The report published Jan. 19 analyzed COVID outcome data from New York and California, which make up about one in six of the nation's total COVID deaths. "Whereas French and Israeli population-based studies noted waning protection from previous infection, this was not apparent in the results from this or other large U.K. and U.S. studies," the CDC said.*
12. **Covid-19 news: US army discharges unvaccinated soldiers** [2/3/22 New Scientist](#) - *US soldiers who refuse to get the covid-19 vaccine are to be discharged from service immediately. Soldiers who are unvaccinated pose a risk to the force and jeopardise readiness, according to a statement from the army secretary Christine Wormuth, yesterday. The new order applies to regular army soldiers, reservists on active duty and cadets. It follows a mandate from the Pentagon last August that all US military service members get fully vaccinated. Around 90 members of the US military have died from the coronavirus so far.*
13. **Japanese Company Says Ivermectin Shows 'Antiviral Effect' Against COVID-19,** [1/31/22 Reuters](#) - *TOKYO, Jan 31 (Reuters) - Japanese trading and pharmaceuticals company Kowa Co Ltd (7807.T) on Monday said that anti-parasite drug ivermectin showed an "antiviral effect" against Omicron and other coronavirus variants in joint non-clinical research. The company, which has been working with Tokyo's Kitasato University on testing the drug as a potential treatment for COVID-19, did not provide further details. The original Reuters story misstated that ivermectin was "effective" against Omicron in Phase III clinical trials, which are conducted in humans.*
